TOP BAND "DRAGON'S FIRE" SIGNAL BLANKETING 160 METERS IN ASIA

The IARU Monitoring System (IARUMS) says radio amateurs in Japan and elsewhere in Asia and Oceania are reporting an unidentified intruder signal on 160 meters. In Japan, the wideband signal, which IARU Region 2 Monitoring System Coordinator Bill Zellers, WA4FKI, has dubbed "Top Band Dragon's Fire," reportedly began transmitting continuously about October 1, blanketing 160 meters and rendering it useless for Amateur Radio work in some areas.

"The intruder is detectable from approximately 1700 kHz up to about 1930 kHz," said one report, likening the sound to "a diesel motor with a ticking sound at a constant rate which is evenly spread across the band." The signal has been heard in the US Northwest at about 1830 kHz on a north-pointing Beverage. Reports also have arrived from New England.

First heard as long ago as December 2004, the signal turns up at different times at different locations, reports indicate. In some cases, it's only during so-called "gray line" propagation, while others hear the signal 24/7. Near Perth, Australia, the intruder was heard slowly rising out the noise floor about a half-hour after sunset, increasing to around S7 and remaining long into the night. Amateurs in Singapore report that the signal recently shifted from wideband noise to a pulsed signal.

Veteran Top Band DXer Tom Rauch, W8JI, in Georgia says he can "just detect a noise floor increase some mornings," but was unable to identify an actual signal.

Board Meeting 13 December

President John Boyd KE6ORI called the meeting to order at 7:40 Pm.

Correspondence:

Received a Christmas card from Raine KG6GII and Frank WA6JTP Strom.

Technical Committee:

A number of projects were discussed. The club missed out, due to failed communications, on a free construction grade light tower and generator. The unit would have been used to construct a portable repeater with 30 foot tower with 4 KW diesel generator. Doug Slusher KF6AKU, Dave Hodgson KG6TCJ, Randy Jenkins KA6BQF and John Boyd KE6ORI are looking into the construction of a portable fill-in repeater for our public service events where we have problems with reliable communications.

A portable enclosure with radio for use in conjunction with the communications truck during events is being constructed by Doug Slusher KF6AKU and Dave Hodgson KG6TCJ.

Repeaters:

The backup 147.330 repeater at the San Pedro site was tested and is working. No other repeater issues were reported.

Building:

John Butler KF6GNI has almost completed the remodeling of the club radio room. Please stop by and take a look at the job well done and take time to operate from one of the stations.

Communications Truck:

The truck still needs a cover to keep the wet weather at bay. Frank Strom WA6JTP has offered to make a contribution to the construction of the cover. John Boyd KE6ORI has changed his work hours so he will be taking the truck to some auto body shops for an estimate to remove the dings and give it a new paint job.

We are considering a new column entitled "The Canal at The End of The Alimentary Tract" awards. (This is a legitimate phrase as we found it in a medical dictionary.) Data would come from the FCC Enforcement Bureau. Here is some, condensed. (But not too much as we have a lot of space to fill when not much newsworthy stuff comes in.)

1. Dear Mr. (deleted):

The Wireless Telecommunications Bureau has notified the Enforcement Bureau that, on its own motion on October 24, 2005, it set aside your application for a General class license on October 21, 2005. That action is based upon complaints about the operation of your station since the grant of your General class license.

The trustee of the N4CLA repeater has requested in writing that you refrain from use of the N4CLA repeater, operating on 144.870/145.470 MHz. The letter was issued as a result of your failure to follow operational rules set forth by the licensee/control operators of the repeater system for its users. You were previously requested verbally to refrain from using the system, but have apparently ignored both verbal and written requests.

Please be advised that we expect you to abide by the request to stay off the N4CLA system and any other such request by a repeater licensee, control operator or trustee. If you use the repeater again after receipt of this letter, we will initiate enforcement action against your license, which may include revocation, monetary forfeiture (fine) or a modification proceeding to restrict the frequencies on which you may operate. Fines normally range from \$7,500 to \$10,000.

2. Dear (name withheld):

The Federal Communications Commission has received complaints that an electric fence charger at your residence may be causing harmful radio interference to an operator in the Amateur Radio Service.

The complainant has attempted unsuccessfully to resolve this problem with your electric fence and as a result the matter has been referred to our office. The FCC prefers that those responsible for the proper operation

of equipment assume their responsibilities fairly. This means that you should resolve the interference caused by the electric fence charger and make necessary corrections within a reasonable time.

Please advise the complainant what steps you are taking to correct this reported interference problem. If you are unable to resolve this by January 13, 2006, please advise this office about the nature of the problem, the steps you are taking to resolve it and the estimated time in which those steps can be accomplished.

3. Dear Mr. (deleted):

Enclosed are complaints filed against the operation of your station. The complaints indicate that you have been operating on 7.290 MHz and other frequencies not authorized to you as a Technician Class licensee. The complaints further allege deliberate interference to ongoing communications. We note also that in a listing you submitted for an Amateur radio licensee database, you claim to be an Extra Class licensee. The complaints and your claim to be an Extra Class licensee raise serious issues regarding your qualifications to retain an Amateur license.

(And about your sanity. ed.)

Section 308(b) of the Communications Act of 1934 gives the Commission the authority to obtain information from applicants and licensees about the operation of their station and their qualifications to remain a licensee. Accordingly, you are requested to review the complaints and respond in detail to this office within 20 days.

In an inquiry of this type we are required to notify you that a willfully false or misleading reply constitutes a separate violation made punishable under *United States Code* Title 18, Section 1001.

Triviabit.

Elderfahrten will remember this thing. It's a SILEX vacuum coffee maker. They were also made by CORY and are still made today by others. The top half had an airtight



seal to the lower part. A tube extended from the upper unit to near the bottom of the lower. Water was added to the lower and ground coffee to the top. A glass rod inserted into the tube from the top kept the coffee grounds, most of them, from getting into the lower half but allowed the water to pass up and the coffee to go down after the heat was removed. The term 'CORY rod' might be familiar. The SILEX equivalent part was equipped with a spring and a hook to insure that it wasn't dislodged from its seat; this did a better job at preventing coffee grounds from passing into the lower pot. In use, after the right amounts of water and coffee were added, heat was applied, usually by a stove burner, until the boiling water had gone up the tube into the upper chamber. Then the unit was removed from the heat and when it cooled a little, the vacuum created in the lower pot sucked the brewed coffee back down. The upper chamber was removed and the coffee served. This is a much better method than the percolator which is only slightly superior to putting ground coffee into last semester's forgotten stiff gym socks and dropping them into a pan of boiling effluent. Serious coffee drinkers don't use percs which boil the coffee and contribute to a bitter taste. Unfortunately, you'll still find them used where large quantities of coffee are required.

CANADIAN AMATEURS TO LOSE 220-222 MHz.

Barring an outpouring of "compelling arguments to the contrary," Industry Canada will reallocate the 220-222 MHz portion of 220-225 MHz from the Canadian amateur service to the mobile and fixed services. Under the provisional reallocation, which will take effect January 25, the amateur service will be allocated the 219-220 MHz subband on a secondary basis. Additionally, the amateur service may be permitted use of 220-222 MHz "in exceptional circumstances on a secondary basis to assist in disaster relief efforts." From the ARRL Letter.

More Stuff: Backyard Smoker.

If you fishermen ever thought about smoking your own catch—or those pork chops, spare ribs or country ribs, etc. from COSTCO—there's an easy, inexpensive way to do that. The LUHR JENSEN line of smokers is available from Bi-Mart membership—\$5 for lifetime—stores in Oregon. These smokers have been sold at places like Longs Drugs and sporting goods stores. Bi-Mart sells them for half of the manufacturer's price. We bought a "Little Chief" smoker, top loader for 48.77. (The maker's price is \$96.36.) Add the five bucks for the lifetime Bi-Mart membership and \$7.98 shipping charges, no tax, and your total is just over \$60 delivered.

The heating element is a CALROD—better known for making kitchen stove burners—250 watt unit. The steel chip pan slides into a door in the lower part of the front side so you can add more smoke w/o disturbing the food.

For specs, go to the LUHR JENSEN website and click on 'smoker products'. To buy, go to Bi-Mart's and in the search area select brand and enter 'LUHR JENSEN'. Bi-Mart also sells the chips of hickory, apple, alder, cherry and mesquite for half (\$1.99) of Jensen's price.

The four racks slide into the lift-out assembly and can go in the dishwasher. Removable Drip pan at the bottom.

In operation there are no flames. The wood is converted to smoke and, later, the cold ash can be dumped into your garbage can. The burn lasts for an hour. We put a thermometer inside which registered 160°. The hickory smoke smelled great. Neighbors peered enviously over the fence.

Not having much raw salmon lying around we did some pork chops with very good results, with the final cooking later. Worked great on ribs, too, which we hung on homemade hooks made from a wire coat hanger.

Old aunts used to come up to me at weddings, poking me in the ribs and cackling, telling me, "You're next." They stopped after I started doing the same thing to them at funerals.
