Board Meeting 14 March.

The meeting was called to order by President Hodgson at 19:31. Present were President Dave, KG6TCJ: Vice-president/ Treasurer Eric, KG6WOU; Secretary Randy, KA6BQF; Board Members Al, W5ALW; Tom, KG6TCM; Kevin, KF6YUF; Raine, KG6GGI; Frank, WA6JTP; John KE6ORI; K6GWE Trustee Doug, KF6AKU; and QSA-5 Editor Phil, K6PHD. Not present was W6SG Trustee Augie, KØCQL.

The agenda was approved with one addition

The minutes of the February Board of Director's Meeting were approved as published in QSA-5. There was no correspondence reported.

President Dave reported that the picnic was scheduled for September 23.

Public Service Chair Randy reported that Chuck Deatrick, WA6SQQ was organizing "The Relay", had about half the required positions filled and is still looking for more people. Randy still needs volunteers for the Miwok on May 6th. Dave and Doug Slusher said they should be available.

Under Technical Committee, Doug reported that when the weather and logistics permit, there will be trip to the Mt. Tam repeater site to do some reconfiguration of the controller. P/M on San Pedro will follow on the agenda. The Tam West input to the 147.330 system was discussed. Tam West and Tiburon site access were discussed. The problem on the 146.700 repeater was discussed. Dave reported that the parts for the APRS trackers were coming together.

Truck Committee Chair John reported that he hasn't done much with the truck recently. He is trying to schedule the generator servicing. There was some discussion of methods to get the body work done.

Hodgson reported that he believed that both education sessions had been completed.

VE Liaison AI Weisman reported that the next VE session would be on Saturday, March 18, and that he was seeking VEs. Jenkins said that he would e-mail the list of VEs. Al commented on the promptness of changes to the website.

As Marin RACES Liaison, Dave had no report. The Yahoo group was discussed.

The Building Manager's Report was deferred to Old Business.

Old Business:

Restrooms. Kitchen. Office. These issues were discussed at length. Comments were made about protecting the building envelope, and roofing options. The question of making the restrooms ADA compliant was raised and discussed. Whether to do a complete remodel or a cosmetic upgrade was discussed. Sequencing, and prioritization of the project was discussed.

A motion was made by John Boyd, seconded by Eric, and amended by discussion, to read: Direct the Building Manager to get three bids for: a) Work to re-roof the building addition and to deal with other existing leaks; and b) An alternate to modify the roof areas over the addition as specified in the remodeling plans; with a report due for the May Board of Director's meeting. Motion Passed.

New Business:

Building Manager John Butler investigated the cost of having regular janitorial service for the building. John had the building vacuumed, and the restrooms cleaned. Prices for the service varied with the frequency of service. Cleaning schedules, and walk-off mats were discussed. The Board tabled the proposal until the May Directors' Meeting.

The Board revisited the issue of spending v. income, in light of the Treasurer's initial report and discussed several possible revenue enhancements and spending curtailments. There was a discussion on investigating the costs involved in changing the heating system for the second floor apartment, to see if it would pay for itself. The Treasurer and the bookkeeper will work to present a more detailed spending report to the Board, and to have a summary report available at the General Membership meetings.

At the suggestion of Director Boyd, Editor Dunlap will investigate the possibility of using the non-profit postage rate on the QSA-5 mailing. (It was found that with less than 200 copies of QSA-5 being mailed, we don't qualify for a postal rate cut. Info from Bill Hillendahl, our San Francisco ARRL Section Manager. ed.)

A steel desk and chair was offered to the club by a member. The Board determined that those items were not needed. Director Tom Jordan said he would To column two, top.

Both of the ICOM-735 radios and the ICOM-765 radio are working and available for Field Day. The grounding system in the radio room has also been completed.

Under Old Business, the status of the restrooms, kitchen and office areas were discussed. President Dave commented that the first priority would be any areas that were leaking. Rich Carbine, W6UDS made some good comments regarding the history of the building and the remodeling plans that had been drawn up, which he still has copies of. There was further discussion of the appropriate approach to follow, including just doing maintenance and minor upgrades.

#### **GENERAL MEETING 3 March 2006**

The meeting was called to order at 19:30 by President Dave Hodgson, KG6TCJ. Other board members present were Eric man, W5ALW; and W6SG Trustee August Koehler, KØCQL.

Guest present was Gary, KD6WSY.

The Agenda was approved as submitted. The minutes of the February General Membership Meeting were approved as published in QSA-5. Secretary Jenkins reported on a thank-you letter received from the parent of a member and that a response was being written.

President Dave reported that Vicepresident Eric Rosenquist had been elected by the Board to serve as the 2006 Treasurer.

Recreation Committee Chair Connie Sawtelle, AE6PA that she had reserved the same great site that we had in 2005 at Samuel Taylor State Park for the 23 September 2006 Picnic.

Public Service Chair Randy reported on upcoming public service events, including the Relay, and the Miwok 100K. Chuck Deatrick, WA6SQQ, who will be heading up the organization of the Relay, made additional comments about the event. The communications request form for organizations that desire amateur radio support from the club was described and it has been posted at the website.

President Dave made the Technical report. The 146.700 repeater still needs to be visited, when weather permits. The Big Rock input to the 147.330 repeater may be becoming "deaf", and a trip will be made as soon as weather and scheduling permit.

Vice-president Eric reported on progress on the APRS project made possible by a generous donation that was made by the Marin Cyclists.

Education Chair Ben Sawtelle, N6PJZ, reported on Technician Classes to be held on March 4 and 11, to be followed by a VE Exam on March 18.

VE Liaison Al Weisman reported that VE sessions had been scheduled for March 18th, June 3rd, and September 2nd. After discussion, the September date was changed to September 9th to avoid conflicting with the Labor Day weekend. The dates have been posted on the website. Al commented on the great job being done by the Webmaster.

Field Day Chair Norm Baetz, WA6CLK, reported that the club had received a letter from the Marin Rod & Gun club about using their facility. Plans are coming along.

#### FAILURE TO RESPOND TO FCC COULD LEAD TO ENFORCEMENT ACTION

The FCC has held up the license renewal of a New Jersey Novice ticket holder for failing to respond to a Commission field office Citation and a Warning Notice, both dating back several years. FCC Special Counsel Riley Hollingsworth told Ronald A. Mondgock, KA3OMZ, of Burlington, that if he did not submit a timely reply to his February 6, 2006, letter, the Commission would dismiss his renewal application and issue a Notice of Apparent Liability for Monetary Forfeiture.

In February 2002, Hollingsworth wrote Mondgock regarding allegations he'd transmitted in the 75-meter phone band, which is unavailable to Novice class licensees. In July 2004, the FCC's Philadelphia Field Office cited Mondgock for allegedly failing to identify, making transmissions involving obscenity and indecency and operating on a frequency not authorized under his license.

On February 7, Hollingsworth sent a Warning Notice to Frank J. Fatigate, KB2YDO, of Hopewell Junction, New York, for allegedly failing to reply to a complaint the FCC forwarded to him nearly a year earlier. The FCC cited US Postal Service records indicating that Fatigate, a Technician licensee, refused delivery of the Commission correspondence. Subsequent attempts to reach Fatigate vielded no response. Noting that Fatigate had apparently changed his address, the FCC gave him additional time to reply or face a possible fine of up to \$4000.

Hollingsworth said this week that he has yet to hear from either Mondgock or Fatigate. Go get 'em!

### Coalinga.

They were Coaling Stations called Gun Club during Field Day w/e. A B and C. Coaling Station A persisted. This story does not stand close scrutiny. A more likely explanation is that Coaling was given the final "a" for musical effect, changing maps to Coalinga. Briefly, the area was also known as Coaling"o". The truth may never be known because the records were burned up in the great quake and fire in San Francisco in 1906 that destroyed the SP railroad's office.
