General Membership Meeting 11/3.

The minutes of the previous meeting were approved as posted on the bulletin board.

President Dave reported on the activities of the Board of Directors:

A committee to suggest changes in the bylaws was appointed and is working. The committee consists of board members Jenkins, Jordan, and Slusher. (see page three)

Odds & Ends: We continue working on the issue of the front door lock. The club brochure had been approved by the board and a copy was available for inspection. A trailer has been donated by Phil K6PHD to replace the old trailer for the generator. The board had approved a proposal by Jessica Vodak, a management student, to study the financial management of the Marin Amateur Radio Society. Board member Frank Strom had inquired about the responsibility for getting programs for the club meetings.

Norm Baetz reported that 21 of the ballots have been returned so far.

Treasurer's Report: Our bookkeeper Connie Sawtelle reported balances of \$11,836.65 in checking accounts before the deposit of the rent check, and \$19,734.75 in savings deposits, for total assets of \$37,141.60. This puts us slightly ahead compared to last year.

Recreation Committee: Connie reported that the Christmas party was coming up and requested RSVP by November 15. After November 15, the price will go up from \$25 to \$30. The Christmas party will be on Sunday, December 3, and will be held in- stead of our normal Friday general membership meeting.

Public Service Committee: Chairman Randy reported that we had our first request for Page two, column three. Page 2 OSA-5

Board Meeting 14 November.

The meeting was called to order by President Dave Hodgson at 1939 hours. Present were Board Members Hodgson, Jordan, F. Strom, Boyd, Foley, Rosenquist, and Jenkins; Trustee Slusher; Editor Dunlap; and Rich Carbine, W6UDS.

The minutes of the previous Board of Directors meeting were approved as e-mailed.

Treasurer: There was a report on our spending for the last two months. Hodgson reported that year to date, we were ahead around \$2000.

Recreation Committee: The Christmas Party is scheduled for December 3.

Public Service: A request for assistance has been received for the Miwok 100 on May 5, 2007.

Technical Committee: Still planning preventive maintenance as time permits. Some users have commented about the differences in audio quality between the receiver at the transmit site and those at the remote link sites.

Comm Truck Committee: We have yet to get a quote from ENG Engineering for rebuilding the tower in the truck. Dave reported that the air compressor had failed during the last field use of the truck but had began working again.

Volunteer Examiner: The next session is scheduled for December 2.

RACES: Dave Hodgson reported on a RACES drill scheduled for November 15.

Building Manager: No report. According to Dave, the leaks through the ceiling of the office area still exist.

Old Business: 1. Dave Hodgson researched the drain culvert running under the east side of the property. There is no record of a County easement that would indicate that they own the culvert. As the property owner, the club is likely responsible for maintenance.

2. The front door lock was discussed again. The consensus of the board was to leave it as it is for now.

New Business: Randy read the proposed amendments to the bylaws. These were discussed by the board and, pursuant to a motion, were accepted for submission to the membership for comment. The board will vote on the amendments at the January Board of Directors meeting.

An Election Committee was selected to count the received ballots at the clubhouse on 19 November. Go to column two.

Proposed Changes to Bylaws.

Some needed changes are listed here for inspection by the membership. A few are typos not corrected previously are not included here; only changes that could effect the operation of the club are shown. Additions in bold type.

Art. 3, Sec. 17. Vacancies, added:

The Board of Directors may grant any director a leave of absence from the Board, for such period as the Board determines is appropriate, without creating a vacancy, provided (1) that such absence shall be determined to be not detrimental to the best interests of the Corporation, and (2) that any director who is also an officer of the Corporation shall relinquish such office prior to being granted such leave. Should a director who has been granted such leave fail to return at the expiration of the time granted, that director shall be considered as having resigned and a replacement shall be named as provided elsewhere in these bylaws.

Art. 4, Sec. 9. Duties of Treasurer.

The Treasurer shall: Receive, or cause to be received, and give receipt for, or cause to be given receipt for, monies due and payable to the corporation from any source whatsoever.

Art. 12, Sec. 3. Admission of Members.

Applicants shall be admitted to membership by written application and payment of current dues, provided that upon a determination by the Board of Directors that an applicant has engaged in conduct materially and seriously prejudicial to the interests or purposes of the corporation, such admission to membership may be denied. Any person denied admission to membership shall have the right to a hearing before the Board of Directors as follows:

- (1) The applicant being denied shall be given an opportunity to request to be heard, either orally or in writing, at a hearing to be held not less than fifteen (15) days after the effective date of the initial denial. The hearing will be held by the Board of Directors in accordance with the quorum and voting rules set forth in these bylaws applicable to the meetings of the Board. The notice to the applicant of his or her hearing shall state the date, time and place of the hearing on his or her proposed denial of membership.
- (2) Following the hearing, the Board of Directors shall decide whether or not the applicant should in fact be denied membership. The decision by the Board shall be final.
- (3) If this corporation has provided for the payment of dues by members, any person denied membership in the corporation shall receive a refund of dues already paid.

USS Wisconsin Radio Club, N4WIS. Listen for us on 12/2, 12/3 and 12/7 between 1400 and 2100 Zulu as that is our next Special Event. Look for us in the General Class area of the highest frequency bands having good propagation. We expect to have two transceivers operating.

MARC's 5KW (advertised) Generator.

The club's generator, which we've written about in past issues of QSA-5 and which has powered us faithfully through a few Field Days, has been mounted on a new trailer. Well, not exactly new, it dates to 1983 and spent most of its life hauling fire wood or just sitting and gathering rust. Most of the rust has been taken care of where it counts. But the price was right. This one has springs and doesn't leap clear off the road like the old trailer when its petrified tires encountered a piece of gravel in their path. It was almost comical to watch, seeing daylight under those tires when you were following it down the road. The relic belonged to the Alto Volunteer Fire Dept. and was probably never designed or intended to travel faster than 25 mph.

With the removal of some of the rust and swap of the old 8 inch wheels for 12 inchers, the new hauler looks pretty sharp. The next step could be the installation of a hitch on our comm van. Hauling duty has been assigned to volunteer vehicles up to now.

Now that there is room on the trailer, we considered adding an additional muffler to quiet it down a bit but tests showed little reduction in radiated sound when jamming a large towel into the exhaust of the running engine. It's mainly mechanical noise. A Scotch Guard treated nylon cover will keep the rain off the parts that count and a crankdown front wheel will take care of leveling fore and aft. Trailers in California under 1500 pounds unladen weigh are exempt from requiring fenders so we're in the clear, there. Small trailers don't need to pay license renewal fees anymore, either. Total cost to the club: one pair of 12 inch wheels and tires.

Now we have to find a sucker to take away the old trailer. Does anyone know of a secluded cliff somewhere that we could push it over and where it won't be found during our lifetimes? ed.
