Dear MARS members,

Greetings from the desk of the President. Spring is in the air!

Now that I am settling into office, and have a better grip on the issues facing the club, I would like to share my observations and opinions with you. It is my desire to see this club continue, and to prosper.

I don't want to be the bearer of bad news, and I'm not placing blame. I'm also not telling you anything that you don't already know. The building's maintenance has been neglected. I don't believe the Board elected me to be 'popular'. It is possible that I was chosen to 'GET THINGS DONE'. If you want to keep THE CLUB HOUSE, changes are going to have to be made in how the club operates. That means we will ALL have to chip in a little. It might mean time and labor, it might mean food, it might mean money.

There are a couple of issues that need immediate attention. I urge club members to attend as many meetings as you can in the coming year and voice your opinions as to how and in what order these issues are going to be addressed. Just like any family with property, maintenance and repairs are an unwelcome but inevitable reality. The income generated by the rental has not been spent on the building. We have been living the 'high life'. Now it is time to budget the remaining resources at our disposal, to 'take care of business' and get the club house repairs started. This will take time; it will not all happen this year. But we need to start NOW.

So far, we have been blessed with a gentle winter. The creek that runs thru the property is in disrepair. I am in contact with the government entity with jurisdiction over the property, to discover who is responsible for repairs and the effects those repairs may have on our neighbors downstream.

The building has dry rot, leaks and insulation issues that severely compromise the safety, health and integrity of the structure. These areas will need to be addressed also. Column three.

#### **General Meeting 2 February**

The meeting was called to order at 1929 hrs by President Denice Stoops. 23 members and guests signed in. Bill Hillendahl, KH6GJV, ARRL SF Section Manager was present.

Secretary Randy reported on incoming communications from the Dipsea Committee and the Marin County Registrar of Voters. Randy was requested to draft a thank you letter to KO6X for a donation of radio equipment.

President Denice reported on the actions of the January Board of Directors meeting. Denice was elected president, Eric Rosenquist was reelected vice president, Randy Jenkins was reelected secretary, and Dave Hodgson was elected treasurer. Denice said that her emphasis this year would be on history, education and Morse code. She reported that the Board of Directors meeting had been moved to the second Thursday of each month. Dave Hodgson added that we would begin sending the club newsletter, OSA-5, via e-mail, soon. Dave also commented that they were still working on a members-only section for the club website that would be password protected, where personnel information like the roster would reside.

Treasurer Dave reported January income of \$2315.00 and January expenses of \$2421.83. Account balances included \$11,906.46 in checking accounts, \$5,593.24 in the repeater certificates of deposit, and \$19,635.73 in the reserve fund certificates of deposit. Dave reminded everybody that renewals for 2007 were being accepted. There was a question from VP Eric about the ATV repeater fund. The history of that particular item was discussed.

Under recreation committee, it was decided after discussion that the annual picnic would be scheduled for September 15. Connie AE6PA will take care of scheduling.

Under public service events, it was reported that we have several events scheduled for this year and we would begin recruiting operators very shortly. Bill Hillendahl requested that we contact the Sonoma group to add the Terrible Two bicycle ride to the list.

Under technical committee, Dave Hodgson reported on repairs to the Big Rock input for the 147.33 system, and that the Tam West input was still down. Trustee Slusher is still negotiating for access to that site. Dave also reported on continuing negotiations regarding the Tam Middle Peak site.

A VE session is scheduled for Saturday, March 3.

President Stoops reminded everyone that we still need a chair for Field Day, which takes place on June 23 and 24th. Rich Carbine suggested a joint Field Day with the Redwood Empire DX Association, REDXA. . The suggestion was well received. Column two.

President Stoops reported on the resignation of building manager John Butler. Vice President Eric reported on three outstanding projects, the awning for the com truck, the culvert at the back of the property, and the pressure reducing valve for the water system.

Good of the Order - ARRL SF Section Manager Bill Hillendahl commented on several subjects including League activities, VE sessions, training classes, protection of amateur radio spectrum, IRLP and public service.

The meeting was adjourned at 2012 hrs.

#### **Board of Directors Meeting 8 February**

The meeting was called to order at 1931 hrs by President Denice Stoops. Present were Board Members Stoops, Weisman, Hodgson, Jordan, Dunlap, Rosenquist, Carbine, Baetz, and Jenkins; Trustees Koehler and Slusher.

Incoming communications included a request for public service assistance from the Dipsea Committee. President Stoops requested that a thank you letter be drafted for our outgoing building manager, John Butler.

Treasurer Hodgson presented a statement of accounts for the month of January. There was discussion about the amount of rent the tenant was paying. Apparently, the full amount due after the 2006 increase was not being received. Dave had also prepared a budget for 2007 that would be discussed under new business. There was a protracted discussion about publication of income and expense accounts in QSA-5. A decision was made to include a limited summary of income and expenses.

Membership - Phil Dunlap is handling the membership committee job. (New rosters will be available after the 2007 dues are in . A dues reminder was in the mail 2/20. ed.)

Recreation - The picnic has been scheduled for September 15.

Public Service - Chairman Randy reported on upcoming events, the Miwok 100, The Relay, and the Dipsea. Solicitations of volunteers will begin shortly.

Technical Committee - Trustee Doug Slusher reported on repairs to the Big Rock repeater input. That system is back online. Also, the Tam West input has come back to life. Doug is still in negotiations with GG NRA to get access to the West Peak site. V P Eric Rosenquist inquired about the status of the stash of Motorola Handitalkies in the storage room. Doug reported, that due to the exorbitant cost of Column three.

re-crystalling them, the plan was to sell the equipment. There was a discussion about the status of the remaining surplus equipment that the club owns. Eric will head up the equipment disposition effort.

Com Truck Committee - Dave Hodgson reported on looking into repairs regarding the tower in the truck. He has obtained schematic drawings and repair instructions for the tower. Parts are available. Dave said that he still needs to get on the issue of the new cover for the com truck awning.

Education Committee - Technician classes are scheduled for February 10 and February 17. Members from the Southern Marin CERT group were attending.

VE Liaison - Al Weisman reported that a VE session was scheduled for Saturday, March 3, and they were expecting a large group of people. Volunteer examiners are needed.

Dave Hodgson reported that NIMS training was now mandatory for all RACES members, courses IC-100 and IC-700, which are available online.

Building Manager - for the interim, Denice Stoops and Rich Carbine have notified the tenant that they are the contacts for anything that goes wrong with the building. Denice has contacted several contractors that she knows to find out if they are interested in working on the building. Tom Jordan may be available for simple calls as he lives nearby. Randy Jenkins has a contractor in San Francisco that he has approached on this subject and who may be interested. Rich Carbine will act as the building manager in the interim and will arrange for any necessary repairs.

Old Business - Treasurer Dave presented a budget for 2007. The board accepted the budget under submission and will take action on it at the March 8 meeting. There was a discussion about the drain culvert at the rear of the property. It

will be inspected on Sunday, February 11. Phil Dunlap reported that a new cover had been obtained for the generator. (The old one blew away in the strong winds of January. ed.)

New Business - The condition of the clubhouse was discussed. President Stoops proposed a general spring cleaning of the clubhouse. Several proposals were discussed. The issue of the thermostat in the clubhouse was discussed at length. Multiple opinions were expressed at length. The building manager will schedule a contractor to look at the furnace and make recommendations. President Stoops reminded everyone that she had proposed a field trip to KPH in West Marin, and was available any time.

Denice proposed rescheduling the July Board of Directors meeting.

Rich Carbine proposed conducting Field Day with the Redwood Empire DX Assn. The Board of Directors formally accepted that proposal.

#### Historybit.

John Henry made history drilling holes for explosives in the Big Bend tunnel (on the C & O RR) which was built from 1870 to 1873. This coincides with the first use of the steam drill. In the contest between Henry and the steam drill, he made two 7 ft. holes while the steam drill made a single 9 footer, getting stuck in a seam in the process and losing time. Eye witness accounts differ on what happened to Henry afterward. The majority agreed, however, that he did not die that night but continued on the tunnel job for some time afterward.

#### From the ARRL web site.

NEWINGTON, CT, Feb 22, 2007 ---

A new Amateur Radio Service regime goes into effect at one minute past midnight Eastern Time. That's when the requirement to demonstrate Morse code proficiency to gain HF privileges officially disappears from the FCC's Part 97 rules. In addition, some 200,000 Technician licensees who have not passed a Morse code exam will acquire HF privileges equivalent to those now available to Novice licensees.

ARRL Chief Operating Officer Harold Kramer, WJ1B, points to the huge and still burgeoning number of exam sessions now on the schedule across the US as evidence that the rule changes will provide a shot in the arm to Amateur Radio.

"ARRL VEC has been extremely busy scheduling new exam sessions," Kramer said. "We normally coordinate about 5500 uled close to 5000 sessions and it's only the end of February." He said ARRL VEC anticipates demand will surge further after February 23.

#### Special Section in March QST

March *QST* includes an eight-page "tearout" section "Now, New Opportunities for *Every* <u>Ham!</u>" (it appears between pages 48 and 49). It focuses on various topics of interest to those gaining new HF privileges through upgrading or owing to the new rules as well as to veteran licensees. Among other things, it covers mentoring -- or Elmering -- new-comers, "The Top 10 Reasons to Try Morse Code," earning ham radio operating awards by using Logbook of the World (LoTW) and a "Welcome to the fascinating world of high frequency (HF) radio!" by ARRL CEO David Sumner, K1ZZ.
