Pres' Msg.

The club has long participated in Field Day. In the past few years we have joined with the Redwood Empire DX Association, with which we share a number of members.

The contest that was chosen is called the California QSO Party. It takes place this year from 1600 UTC Saturday 1 October to 2200 UTC Sunday October 2. The object of the contest is "Stations outside of California work as many California stations in as many CA Counties as possible. Stations in Clifornia work everyone". The contest has been run in various forms since 1966 and is currently organized by the Northern California Contest Club. This contest gets participants from all over the world, all trying to communicate with us in CA.

We will augment our existing equipment with some gear that the heavy hitters use. We will provide orientation sessions in the weeks prior to the contest to introduce those of us who are not experienced at contesting to how it works and how to behave. We will provide the radios, antennas, computers, software, and training. Work for an hour, or work around the clock. Column two.

We will work as many modes and bands as possible. Along with experienced contesters to explain and guide you, we will provide food, and of course the opportunity to watch and listen.

We have over a hundred members but only about a quarter of us make it to the monthly meetings. Our vice president Jerry Foster WA6BXV has organized a series of very interesting presentations at our regular monthly meetings, and attendance is up because of it. THE WAYBACK MACHINE ISSUE #35 by Bill Continelli, W2XOY reprinted with permission.

Over eight years ago, I started the "Wayback" columns. At first, they were designed to be fillers in the Schenectady Museum Amateur Radio Association's newsletter, but soon, they took on a life of their own, thanks to the Internet, and mented again on the encroachment of the "This Week in Amateur Radio" where the columns were translated into 10 minute "broadcasts", sent out over 100 repeaters nationwide. After writing Wayback #34 in early 2003, I prepared the research for #35 then, for some unexplained reason, took a prolonged break. I knew I would come back, I just wasn't sure when. Two separate incidents brought me back. The first was the subtle (and not so subtle) pressure from two of my most faithful newsletter editors, who have run each and every "Wayback". (Thank you Marian and Ken). The second was the present day activity in southwest Washington State, where the possibility exists of a repeat of events that occurred in 1980.

On March 27, 1980, smoke and ash began pouring from Mount St. Helens, a supposedly dormant volcano in southern Washington. Scientists were unsure if this was just a prelude to a major eruption, but they weren't going to take any chances. Monitoring stations, equipped with scientific instruments, were set up around the mountain. The Washington State Department of Emergency Services sprang into action. RACES was activated, and hundreds of amateur radio operators, through HF and VHF RACES and ARES nets, began helping West Texas, to be exact. The family had the geologists and scientists. Hams acted as scientific observers, as well as communications operators from numerous remote locations, transmitting information on the volcanic tremors, as well as the amount of smoke and ash venting from the mountain. A few days after the March 27 activity, the mountain once Whereupon, his father called out to again became somewhat dormant, and the amateur operations were scaled back.

Then suddenly, without warning, at 8:32 am on Sunday, May 18, 1980, Mount St. Helens literally blew up. The top 1300 feet of the mountain was blown apart by an explosion inside the mountain which had the force of a 10 megaton atomic bomb. Volcanic ash was thrown 60,000 feet into the air. The top part of the mountain came down the side of the volcano, crushing and destroying everything in its path for miles.

Over 10 miles away, Jerry Martin, W6TQF, was at his observation post, "Coldwater 2". He was the first to see the explosion, and he transmitted the first warnings, which activated the state DES. Ominously, contact with W6TOF was lost just a few minutes after his warning. More ominously, no one had heard from Reid Blackburn. KA7AMF, who was much closer to the volcano. He had been killed by the hot volcanic ash that buried his location. As for W6TQF, his observation post was destroyed by the explosion, ash and mudflows.

Meanwhile, a massive cloud of volcanic ash from the eruption began drifting toward populated areas, raining ash and lightning in an ever increasing path. Amateur radio nets on 147.06, 3.987, and 3.940 MHz relayed wind direction and ash-fall information to towns in the cloud's path. Amateur Radio became the key communications link during the next few days, as the first cloud eventually drifted to the East Coast. But it wasn't over.

Exactly one week later, at 2:49 AM, on Sunday, May 25, 1980, Mount St. Helens erupted again. This time the ash drifted northwest, toward the ocean beaches. Hundreds of Memorial Day vacationers evacuated to escape the ash fallout. Amateur Radio operators kept the Washington State DES headquarters informed of the mountain's actions. Hams also kept County emergency services offices informed about the path of the second ash cloud. Local officials used the amateur radio data to plan evacuations, or other necessary activi-But it still wasn't over. ties.

On Thursday, June 12, 1980, at 9:11 PM, Mount St. Helens erupted for a third time. This time, the ash drifted southwest over Portland, Oregon, closing the airport. Again, Amateur Radio operators provided information regarding the eruption and the path of the ash cloud.

In the end, over 300 hams were active. passing reports, mountain observations. and data to emergency service offices around the state. Almost 3000 messages were passed via Amateur Radio. And let us never forget that two Amateur Radio operators, Jerry Martin, W6TQF, and Reid Blackburn, KA7AMF, made the ultimate sacrifice in providing public mittee for further information. service to their fellow man.

In our next installment, we will go back 20 years, and look at the events of 1984. I hope you can join me.

Subject: Excerpts from a May 1935 NATIONAL GEOGRAPHIC article by Amelia Earhart, "My Flight From Hawaii."

"On 22 Dec 1934...set off from LA to Honolulu...on Matson's LURLINE. ...we ran the motor several times...and tested the radio...we picked up familiar airway station signals...Sparks the LURLINE radio operator was much interested in our set and was extremely helpful." "..departed Wheeler Army Field...11 Jan 1935...as the radio operator on Matson's MALIKO broadcast to shore stations that I had been sighted 900 miles from Honolulu."

About midway the Ramapo, Navy tanker, reported me, but I missed seeing her..

TWO-WAY RADIO TELEPHONE

Mine was the first civilian long-distance flight made with two-way radio telephone. This equipment, of course, is regularly used on the air transport lines in the United States, but hitherto has been perhaps too heavy, costly, and complex to find a place in record flying.

My outfit, in addition to the usual set for beam reception, included a 50-watt transmitter with a possible sending range of more than 2,000 miles. My call letters are KHABQ (a mouthful indeed!) assigned by the Federal Communications Commission under a special license for communication at sea, with frequencies of 6,210 and 3,105 kilocycles. On the Pacific voyage I received certain commercial broadcasting stations, tuning the stations low except when the stations 'talked' to me.

I was scheduled to transmit at a quarter to and a quarter past the hour. The radio itself was operated by remote control and was situated in the rear of the plane, behind the fuselage gas tanks. In the cockpit I had a dial for tone and sensitivity control and volume, a selector switch, and a handheld microphone.

To broadcast, I rolled out the antenna through a hole in the floor by means of the reel under my seat. The antenna was weighted with a small lead ball and streamed out in an arc below the plane in flight—adding another thing for a pilot to think about when taking off or landing, for it had to be reeled in then.

Commercial stations which generously cooperated with me before and during the flight were KGU in Honolulu, **KPO in San Francisco**, and KFI of Los Angeles. The latter put on a special all night program, relayed information, and otherwise kept in touch with me every half hour. The Department of Commerce shortwave airway stations on the coast and at Kingman, Arizona, also stood by for the duration of the flight. They, **and the amateurs who cooperated**, can never know how much they helped a lone pilot.

Only few hours before the start, I happened to hear the KGU announcer say: "We are interrupting our musical program so that Mr. Putnam may try to communicate with his wife."

And then, some hundreds of miles out over the Pacific, I heard my husband's voice as though he were in the next room. "A.E," he said, "the noise of your motor interferes with your messages. Please speak a little louder."

A few minutes later I talked back to him through the little cup microphone—louder. As requested.

Within a few minutes KPO, in answer to my query, radioed me the position of the *President Pierce* as 300 miles out from San Francico. I did not pull up again to 8,000 feet, but flew at about 1,500 the rest of the way to shore.
