The Dog Days of Summer

Dog Days were popularly believed to be an evil time "the Sea boiled, the Wine turned sour, Dogs grew mad, and all other creatures became languid; causing to man, among other diseases, burning fevers, hysterics, and phrensies." according to Brady's Clavis Calendaria, 1813.

July and August seem to be the slow months in ham radio. The HF bands are quiet for the most part and the sunspot cycle is not helping the propagation. Yet here in our area we have the opportunity to try a local contest on VHF.

The San Francisco Radio Club is sponsoring the 2015 San Francisco 2 Meter FM QSO Party. It is designed to give 2 meter operators a fun contest to work others via simplex. The QSO party takes place on Saturday August 29th, 2015 starting at 12 noon (1900 UTC), and runs for 6 hours. Contacts are limited to FM Simplex on the 2 meter band, and at least one end of the QSO must be within San Francisco. Participants are entered as either fixed or mobile. The exchange is call sign and zip code. If you are mobile your zip can change. Scoring is based on zip codes and a logging program is available for you at http://sfsunset.com/logger/. Should the HF bands cooperate in August, there are state QSO parties and the North American QSO Party. The NAQP could provide the opportunity to work many states and its limit of 100 watts makes it possible for even modest stations to join the fun.

Kudos to Doug, KF6AKU, and Randy, KA6BQF, for all of their work in organizing and running a successful club auction. Not only did the club bring in about \$2,200 from the auction, but some of the operational transceivers were bought by club members to use.

Radio Amateurs Join ISS Crew:

Two radio amateurs were among the three new International Space Station (ISS) crew members, who arrived on station on July 23 (UTC). Kjell Lindgren, KO5MOS; Oleg Kononenko, RN3DX, and Kimiya Yui traveled into space aboard a Russian Soyuz spacecraft that has docked with the ISS. Expedition 44 Commander Gennady Padalka, RN3DT, and Flight Engineers Scott Kelly and Mikhail Kornienko, RN3BF, were on hand to greet the trio. Lindgren, Kononenko, and Yui will stay on the ISS until late December. Kelly and Kornienko are a few months into a 1-year mission that ends next March. Padalka, who also has been aboard since March, returns to Earth in September.

ARRL HF Band Plan

The ARRL Board adopted amendments to the ARRL HF Band Plan that were recommended by the HF Band Planning Committee, with one major change from the proposals as outlined in the April 2015 issue of *QST* and summarized on the ARRL website. That change was to set the upper RTTY/data limit for 20 meters at 14.125 MHz, consistent with the IARU Region 1 band plan.

Rule Making Petition to FCC

The Board authorized the preparation of a rule making petition to the FCC, seeking changes in the 80 and 75 meter bands that are consistent with majority opinion among more than 1000 responses to an online membership survey. The petition would seek to shift the boundary between the 80 meter RTTY/data subband and the 75 meter phone/image subband from 3600 to 3650 kHz. It also would restore privileges in the 3600-3650 kHz segment to Advanced, General, Technician, and Novice licensees.

In addition, the League will ask the FCC to shift the automatically controlled digital station (ACDS) band segment from 3585-3600 kHz to 3600-3615 kHz, consistent with the IARU Region 1 and Region 2 band plans, and authorize Technician and Novice licensees to use RTTY/data emissions in their 15 and 80 meter band segments, the latter change contingent on expansion of the 80 meter band.

FCC News

FCC to Close Field Offices

The FCC announced it will close field offices at or near Seattle, Anchorage, Buffalo, Detroit, Houston, Kansas City, Norfolk, Philadelphia, San Diego, San Juan (Puerto Rico), and Tampa.

Enforcement Bureau field offices in or near Atlanta, San Francisco, and Columbia (Maryland) will relocate to FCC-owned sites nearby or in the same metropolitan areas. Locations to remaining open in or near New York City, Miami, Dallas, Chicago, Boston, Denver, Honolulu, New Orleans, Portland (Oregon), and Los Angeles. Staff and equipment will be maintained at these locations.

The FCC still plans to implement rapid deployment teams from Columbia Maryland and Denver. These teams will support nationwide high-priority enforcement actions.

Pampanito Report

Our station NJ6VT was up and running around 1045 hours aboard the USS Pampanito on Saturday, June 11th for our regularly scheduled DDO. HF radio conditions were rather disappointing on the 40 meter band with the absence of short skip. Very few stations were heard and no QSO's were made early on. No other museum ships were heard. The Big Rock repeater on 146.700 was monitored from 1100 to 1115 hours for Pampanito traffic, but no traffic for the boat was received.

After lunch, the noise level rose substantially to solid S5 - S6 across the entire 40 meter band making communications all but impossible. A solar flare radiation disturbed the ionosphere and radio propagation was compromised for the rest of the day. Doug McCasland, KJ6OYJ, made a few QSO's on the 20 meter band and I tried to contact our friend Jose, KP3W, in Puerto Rico on a pre-arranged sked on the 17 meter CW band at 18.080 mc. Very few signals were heard on the 17 meter band at that time and many calls to KP3W went unanswered. I heard from Jose later by email that conditions were the same at his QTH. Maybe next time we will have better luck! Visitor traffic aboard the boat was light to moderate. Most visitors were from California this time around.

Our next DDO is set for Saturday, August 8, 2015 aboard the Pampanito. Let me know if you are interested in helping out.
