ARRL News ARRL's Logbook of The World Tops 1 Billion QSO Records



First FT8 Roundup is a Huge Hit

The first FT8 Roundup over the December 1 - 2 weekend <u>attracted</u> some 1,300 logs from those taking advantage of the ever-morepopular digital protocol. This, despite its having been announced on fairly short notice and with other events such as the ARRL 160-Meter Contest on the same weekend. More than 400 of the logs were from US radio amateurs in the 48 contiguous states, plus the District of Columbia. Overall, some 131,200 contacts were recorded. Participants from 91 countries submitted logs, testifying to the fact that FT8 is not just a US phenomenon.

"The FT8 Roundup was the last shakedown for the *WSJT-X* 2.0-rc5 beta software," said well-known RTTY contesting enthusiast and expert Don Hill, AA5AU, an FT8 cosponsor with Ed Muns, W0YK. "It performed with no major complications." The general availability release of *WSJT-X* 2.0 is now out, and it's not backward compatible with *WSJT-X* 1.9 or earlier versions. Developer Joe Taylor, K1JT, has urged users to upgrade by January 1 to what now is the new world standard.

General Meeting Minutes December, 2018

No minutes submitted.

Board Meeting Minutes November, 2018 Marin Amateur Radio Society Board Meeting Minutes November 8, 2018

7:30 PM President Curtis Ardourel calls the meeting to order. He will entertain any additions to the meeting agenda. A member wants to talks about LED versus florescent lights at the clubhouse. Curtis will add that discussion about replacing the ceiling florescent lights. The agenda is adopted by a motion, second, and unanimous votes. The minutes of the October 11, 2018 MARS board meeting are adopted by a motion, second, and a vote.

No secretary's report. Ed Essick talks about October 9, 2018 about mail. Cleaning the drainage. Did anybody come? No one knows. The Marin County Elections commission would like to use the Alto clubhouse on March 5, June 4, and November 5, 2019. Doug Slusher Building and Facilities manager says that they are always welcome to use the facility and have done so in the past. Cal asks if anyone emptied the food money jar, thinking that maybe the elections people may have taken it. No one knows. Ed Essick, who is the treasurer, will return the form to the elections commission via Doug. Doug has a working relationship with the elections setup committee who use a moving truck routinely. Ed has paid the PO box fee and the post office is generating another key for the PO box. Doug says that then MARS will have 3 because he has contacted Jennifer Dunlap, who has the old key from SK Phil Dunlap. She will return the key to Doug, who in turn, will give it to Ed or the secretary. Doug adds that the club got all of Phil's ham gear. Doug mentions changing the secretary name the Secretary of State listening for the the MARS club.

Treasurer's report. Ed Essick reports that Mike Ransom is in hospice care at his home with not long to live. Mike is a long term club member and Elmer at MARS. Ed requests that board members write cards which he will deliver to Mike at his home. Ed is helping with Mike's care. Ed put the copy in QSA-5 but here is another copy. Curtis had an expenditure of \$300.00 for website hosting. The first page shows the "P and L" details. Ed recaps the entries on the report and is grateful that the tenant now makes rent payments by electronic transfer. Doug Slusher says that the tenant is happy with the current and new rental arrangements. Doug asks Ed about the payment of the property taxes for the MARS club. Ed paid the first half of the amount. Facilites. Doug says that the estimate he has for roof repair is \$37,000.00. MARS still hasn't received a previous bill from this contractor-the one who gave the estimate. The club repair is small cost-that may explain the lack of a bill. Doug says that Yaesu has the money for the digital repeater upgrade. Work is still pending however and thus frustrating. There are problems between the Fusion Model 1 and 2 repeaters-this is slowing the upgrade time. Doug has SK Phil's equipment at his house and has made an inventory for the club. There is discussion about possible repairs to his equipment. Doug wants to push the board in 2019 to devolve and sell excess equipment at the Alto clubhouse. Doug and Curtis talk about the sales and work involved of getting rid of the excess equipment.
